

REGISTRATION, FUNDRAISING COMMITMENT AND RELEASE

FUNDRAISING COMMITMENT

I acknowledge and accept responsibility to raise at least **\$1,000.00** for Girls on the Run of Montgomery County on or before Friday, **August 29th, 2008**, in order to participate in the Marine Corps Marathon (“MCM”) Training Team program and to qualify through that program for registration in the 33rd Marine Corps Marathon scheduled for Sunday, **October 26, 2008**. I understand that I will be required to honor the balance of that commitment by making a personal contribution if I do not raise at least \$1,000.00. I understand that I will receive my MCM Entry only upon completion of this fundraising commitment.

I acknowledge that all contributions made to Girls on the Run of Montgomery County are non-refundable, even if I do not participate in or complete the MCM, or if the MCM is canceled for any reason.

WAIVER OF NEGLIGENCE AND COMPLETE RELEASE OF LIABILITY

I am fully aware and acknowledge that training for and running a marathon may result in accidents, serious injury or death. By signing this Waiver and Release, I declare that I am medically able, properly trained, physically fit and capable of participating in a marathon training program and running a marathon and that my medical care provider has approved my participation. I verify that I have full and independent knowledge of the rigors and risks involved in running in a marathon and of participating in a marathon training program. I am voluntarily participating in a marathon training program and running a marathon with complete knowledge of such risks, and I accept full responsibility and assume all risks of injury or death.

I am fully aware and acknowledge that medical support for marathons consists primarily of volunteer personnel trained to administer first aid during the event and that any assistance they provide is not being rendered as medical advice. I agree independently to consult my personal physician in the event of any injuries or medical questions arising from or related to my participation in the MCM Training Team and, if applicable, the MCM. I also acknowledge full and sole responsibility for my own medical expenses and that I am responsible for any and all medical expenses incurred on my behalf.

I am fully aware and acknowledge that Girls on the Run of Montgomery County is not responsible for and has no role in the MCM. I am also fully aware and appreciate that no federal or Marine Corps endorsement or sponsorship of Girls on the Run of Montgomery County is implied by the arrangement between the MCM and Girls on the Run of Montgomery County.

I acknowledge that the training for the MCM Training Team will be provided primarily by the Montgomery County Roadrunners’ Club. However, representatives of Girls on the Run of Montgomery County also may provide training advice as part of the MCM Training Team program. In consideration for being permitted to participate in the MCM Training Team program, I agree to assume all risks associated with the MCM Training Team or the running of the MCM, to waive any negligence of, and to completely release and hold harmless, Girls on the Run of Montgomery County, all affiliated organizations, the Montgomery County Roadrunners’ Club, all other training groups and organizations involved in the MCM Training Team program, designated beneficiaries, sponsors, first-aid volunteers, officials, participating clubs, communities, organizations and all government or public entities (and their respective officers, agents, directors, employees or members) who through negligence, carelessness or any other cause, might otherwise be liable to me. I understand and agree that this Waiver and Release is binding upon my heirs, assigns and legal representatives.

I hereby grant my consent and permission to Girls on the Run of Montgomery County, their licensees, affiliates or employees, to use any and all information submitted in my application, and/or my name, photograph, videotape, motion picture recording, voice or likeness for any purpose, including pre-race and post-race publicity.
